Additionally, citing relevant studies or empirical evidence supporting this claim would strengthen the credibility of the findings.
5. The abstract mentions that the study focuses on the demands and attitudes of administrators from the local government sector. It would be valuable to elaborate on the specific demands and attitudes explored in the study. For instance, are there any common challenges related to resistance to change, lack of IT awareness, or limited budget allocation? More insights into these aspects would enrich our understanding of the difficulties faced during IT implementation in the local government context.

3. The second finding highlights the influence of executives' IT competence levels on IT development and deployment efficiency. It would be beneficial to explore further how these competencies can be improved or developed among executives in the local government sector. Providing recommendations for training programs, skill assessments, or knowledge-sharing platforms would help address the identified competency gaps.
4. The keywords selected are relevant to the study, but it would be valuable to expand the keyword list to include terms related to change management and stakeholder engagement. These aspects are crucial in overcoming resistance to IT implementation and fostering collaboration among different stakeholders. Expanding the keyword list would attract a wider audience interested in these specific areas.
5. In the abstract, the study mentions "*New Public Services*" as one of the keywords. It would be helpful to clarify how the concept of new public services relates to the challenges and difficulties discussed in the study. Providing a brief explanation or defining the concept within the context of the article would enhance the readers' understanding of the topic.
